

# Regulation No. 161/2021 of the Rector of the University of Opole of December 08, 2021

on amending and issuing the consolidated text of Regulation
No. 44/2018 of the Rector of the University of Opole of 28 August 2018
on monthly fees for a place in student and guest rooms in the Halls of
Residence of the University of Opole

Pursuant to **Article 23(2)(2), Article 79(2)(6),** in conjunction with **Article 80(3)** of the Act of 20 July 2018 - the Law on Higher Education and Science (Journal of Laws of 2021, item 478 as amended), in conjunction with **Section 26(1)** of the Rules on Benefits for Students and Doctoral Students of the University of Opole (Regulation No. 117/2021 of the Rector of the University of Opole of 15 September 2021), **the Rector of the University of Opole** hereby orders as follows:

## Section 1

In the Regulation No. 44 /2018 of the Rector of the University of Opole of 27 August 2018 on the monthly fee for a place in student rooms and guest rooms in halls of residence of the University of Opole is amended as follows:

## 1) in **Section 1**:

- a) **subsection 1** is amended as follows:
- 1. Rates for a place in a student room for students and doctoral students of the University of Opole:

- 6) **Section 5a** is repealed
- 7) **Section 5b** is repealed
- 8) after section **5(b)**, section **5(c)** is added, which shall read as follows:
- 1. A student or doctoral student may be exempted from the fees referred to in sections 1 and 3 in full or in part.
- 2. The total exemption referred to in subsection 1 shall apply to the entire fee referred to in sections 1 and 3. The partial exemption cannot exceed 50% of the fee.
- 3. A student or doctoral student may apply to the Chancellor for total or partial exemption from the fees referred to in sections 1 and 3.
- 4. A student or doctoral student may apply for exemption referred to in subsection 1 only in exceptional and justified cases, in particular:
  - 1) a particularly difficult financial situation,
  - 2) a long period of hospitalisation.
- 5. A request referred to in subsection 3 should include a set of documents confirming the circumstances justifying the granting of exemption.
- 6. If the documentation referred to in subsection 5 has not been drawn up in Polish, a certified translation into Polish should also be presented.
- 7. The decision on the request is made by the Chancellor.
- 8. The decision referred to in subsection 7 may be appealed by an application for reconsideration, which should be submitted to the Rector via the Chancellor within 14 days of the receipt of the decision.
- 9. The decision of the Rector made after reconsideration referred to in subsection 8 is final.
  - 9) **Section 6** is amended as follows:
- 1. Additional charges: pets, bed linen hire service:

- 3. The fee for renting a module (2 rooms with kitchen and bathroom) in the Niechcic Hall of Residence is set individually by the Chancellor.
- 4. The fee for half a month means the payment for the period from 1-15 or 16-30 (31), or 15 consecutive days.

#### Section 2

The remaining provisions of Regulation No. 44/2018 of the Rector of the University of Opole of 27 August 2018 on the monthly fee for a place in student and guest rooms in the Halls of Residence of the University of Opole remain unchanged.

## Section 3

The consolidated text of Regulation No. 44/2018 of the Rector of the University of Opole of 27 August 2018 on the monthly fee for a place in student and guest rooms in the Student Dormitories of the University of Opole is announced in the Appendix hereto, taking into account the amendments introduced by:
