I. Fees for repetition of certain courses on full-time studies due to unsatisfactory academic performance

* Fees paid by the candidate are not refundable with the exception of the following cases:

- a) the programme has not been opened due to the lack of the sufficient number of candidates;
- b) the candidate has erroneously paid a higher amount of money;
- c) no enrolment in the programme (withdrawal of enrolment is possible at the latest on the registration deadline specified in the admissions schedule);
- d) payment of the fee after the due date;
- e) invalid registration – no secondary school leaving certificate (failed secondary school leaving examination) or diploma (studies not completed).

The fee shall be reimbursed upon a written request from the candidate submitted by October 31, 2025 (summer admissions), or by March 31, 2026 (winter admissions). Instructions for

proceeding and a template application form can be found on the University of Opole website under "Candidate - Studies 2025/26 - Registration Fee". The application confirmed by the Rector's Proxy for Admissions is directed to the Accounting Office and the refund is made to the account given by the candidate.
